They would also move another \$5,000 into Sponsorships to fund sponsorship opportunities throughout Randolph County and another \$5,000 in Promotional Materials for items needed for events in Randolph County. Then, the TDA would like to put \$4,000 into Advertising to help support our attractions in Randolph County. Then, \$16,000 will be placed into Brochures to aid the purchase of the quantity of 75,000 order of the 2024 Randolph County Travel Guide.
